Sl. No.	The school is directed to ensure that:	
1	The total number of sections of the school shall be restricted to 15 of which not more than 1/3rd sections may be used for senior secondary classes. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by e law subject to availability of class rooms of greater than 500 sq ft dimension.	
2	There are sides slabs constructed in the biology and physics lab, which are not suitable for conducting practicals and chair are being used for the seating. Thus, the school is directed not to use the said slabs for conducting practicals and replace the chairs with wooden stools in all of the science labs within 03 months and submit the videographic evidence on SARAS Portal.	
3	The composite science lab is temporarily arranged, which is a makeshift arrangement. There are no permanent fixtures, washbasins, water and gas connection in the workstation, proper storage facilities, and safety features such as fire extinguishers and exhaust fan. Further, white cloth has been placed on the table, which is a fire hazard. Thus, the school is required to upgrade the said lab as per above and Board's SoP within 03 months and submit the compliance.	
4	The mathematics lab is temporarily arranged and under stocked. Thus, the school is required to set-up the same as per Board's SoP with sufficient seating arrangement, storage facilities and more math's equipment within 03 months and submit the invoice of newly purchased equipment and videographic evidence in the compliance.	

	5	The school shall conduct training of its teachers with CoE Noida within 3 months and submit

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo /society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7. Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.
